Bank cash deposits are being made as needed. At least one more year of using the same operating model. September 2025 soonest date for hires for new positions. Langham has a target of \$300,000 to be in the bank by August 30, 2025 -- \$100,00 in Operating account and \$200,00 in Building/Equipment reserve.
